Partial Reports Evaluation and Control Plan

In the spring, we published the evaluation of the partial project reports for 2023, which took place at the individual meetings of the expert evaluation panels and subsequently at the meeting of the AZV ČR Scientific Board. Out of the total of 334 submitted partial reports, 333 projects were recommended for further implementation, while 32 projects were evaluated with reservations, and 1 project was evaluated as not fulfilled. We would like to remind you that the assessments on the partial reports are published in the ISVP (https://ereg.ksrzis.cz/) in the details of the specific project. Please pay attention to all reservations identified in the evaluation and which can be found in the evaluation report or commentary. In total, 23 non-accepted results were found and 22 projects were proposed for control activities. Planned audits are already underway and will continue until February 2025. Thank you for your cooperation!

Join the European Partnerships in Health

By its resolution of 22 May 2024, theGovernment of the Czech Republic approved the amendment of the Programme for Support of Applied Health Research for the years 2024–2030. The amendment of the Programme consists in its extension by Sub-programme 3: European Partnerships in Health, where the announcement of 6-7 co-funded transnational calls with a contribution from the European Commission for each European partnership is planned. At the national level, the calls will be managed by our Agency, which will further specify the eligibility criteria and obligations of Czech applicants. Information about current calls will be published on the AZV ČR website.

The total expenditure for the duration of Sub-programme 3 in 2025-2030 is expected to amount to CZK 337.5 million from the state budget expenditure on research, development and innovation. These expenditures are distributed in accordance with the expected phasing of transnational calls and in relation to the expected 3-year duration of the projects.
